Your letter dated February 27, 2024, submitting replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SBP150500\_005, in the amount of \$1,210,000, was received by our office on March 11, 2024. This bond, conditioned to cover Right-of-Way OCS-G 16048, was executed on February 27, 2024, with Panther Operating Company, LLC as principal and Pennsylvania Insurance Company as surety.

This bond replaces Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0038052, in the amount of \$1,210,000. This bond, conditioned to cover Right-of-Way OCS-G 16048, was executed on March 30, 2016, with Panther Operating Company, LLC as principal, and Argonaut Insurance Company as surety.
