Enclosed are the following documents for filing with your records:

- 1) Assignment of Notes, Liens, and Security Interests dated December 31, 1991 (the "Assignment"), delivered by First Interstate Bank of Texas, N.A., a national banking association ("FITX"), to A/S Investa, a Norwegian corporation ("Investa");
- 2) Deed of Trust, Modification, Extension, and Renewal Agreement dated December 31, 1991 (the "Amendment"), which has been delivered by Ivory Production Co., a Delaware corporation ("Ivory"), to Investa; and
- 3) Copy of the Special Power of Attorney pursuant to which Investa granted to the undersigned the authority to execute the Amendment on its behalf, certified by the County Clerk of Brazoria County, Texas.


