**MEMORANDUM OF RIGHTS CREATED UNDER CONSULTING
AND MANAGEMENT AGREEMENT**

Re: OCS-G 10211, Brazos Area, Block 364

TO WHOM IT MAY CONCERN:

This memorandum shall serve as notice to any party having or acquiring an interest in the subject lease or any well and/or equipment, or oil and/or gas produced from any well situated on the subject lease ("property") of the existence of certain rights in and to the ownership of the property by virtue of that certain Consulting Management Agreement dated March 31, 1981, by and between Norse Petroleum (U.S.) Incorporated ("Norse") and R. L. Duncan, Inc. ("RLD") ("Consulting Agreement") which Consulting Agreement was extended, renewed and amended by Letter Agreements dated May 11, 1982, February 17, 1983, April 3, 1984, April 3, 1985 and April 10, 1987, which Consulting Agreement and Letter Agreements are hereinafter sometimes collectively referred to as "Agreement". The Agreement provides for the assignment of certain rights and interests in the property in favor of RLD. Any party acquiring an interest in the property is hereby placed on notice of the existence of the rights, privileges, and interests of RLD with respect to such property.
