

# ASSIGNMENT OF OVERRIDING ROYALTY INTEREST

KNOW ALL MEN BY THESE PRESENTS THAT:

THIS ASSIGNMENT OF OVERRIDING ROYALTY INTEREST (this "Assignment") is from Michele W. Henderson, as Independent Executrix of the Estate of Robert E. Henderson, Deceased, whose address is 12710 Cobblestone, Houston, Texas 77024 ("Assignor"), to Michele W. Henderson, Trustee of the Robert E. Henderson GST Exempt Family Trust, whose address is 12710 Cobblestone, Houston, Texas 77024 ("Assignee").

}

WHEREAS, Robert E. Henderson (the "Decedent"), a resident of Harris County, Texas, died on July 6, 2016. The Decedent left a Will dated December 22, 1994 and First Codicil thereto dated April 1, 2010 (collectively, the "Will"), which Will was duly admitted to probate as the Last Will and Testament of the Decedent in Probate Court No. 4 of Harris County, Texas, in Cause No. 450,272. Michele W. Henderson (the "Independent Executrix") duly qualified as Independent Executrix of the Estate of the Decedent (the "Estate") and she continues to serve in such capacity.

WHEREAS, the Decedent is survived by his wife, Michele W. Henderson (referred to in her individual capacity as "Mrs. Henderson"). At the time of the Decedent's death, Mrs. Henderson and the Decedent owned certain Oil and Gas Overriding Royalty Interests (collectively, the "ORRI") in the Oil and Gas Leases shown on Exhibit A attached hereto and made a part hereof (collectively, the Leases) as their community property estate. Upon the Decedent's death, the community property estate of Mrs. Henderson and the Decedent terminated so that all of the former community property assets relating to the ORRI of Mrs. Henderson and the Decedent are owned in equal undivided shares, one-half by Mrs. Henderson and one-half by the Assignor, which division was confirmed in the administration of the Estate of the Decedent.

WHEREAS, Assignor delivers this Assignment to Assignee pursuant to the terms of the Will and the administration of the Estate of the Decedent.

NOW, THEREFORE, Assignor does hereby assign, transfer, grant and convey unto Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the ORRI in the Leases, together with any rights and interests of Assignor attributable or allocable to the Leases by virtue of pooling, unitization, communitization, and operating agreements (collectively, the "Interests").

TO HAVE AND TO HOLD the Interests unto Assignee, its successors and assigns, forever.

THIS ASSIGNMENT IS EXECUTED, DELIVERED, AND ACCEPTED WITHOUT ANY REPRESENTATION, WARRANTY OR COVENANT OF TITLE OF ANY KIND OR NATURE, EXPRESS, IMPLIED OR STATUTORY.

This Assignment shall inure to the benefit of and be binding upon the parties hereto, their successors and assigns.


