

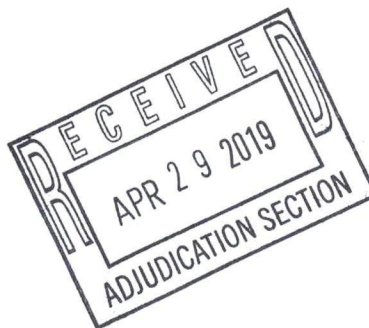

**RATIFICATION OF PARTIAL RECONVEYANCE OF

This Ratification of Partial Reconveyance of Overriding Royalty Interest, Release and Relinquishment (“**Ratification**”) is executed by **Stork Holdings Corp., (as predecessor in interest to Stork Holdings I LLC)**, a Delaware corporation, whose address is 345 Park Avenue, 44th Floor, New York, New York 10154 (referred to herein as “**Apparer**”) and made effective April 1, 2018.

WHEREAS, by instrument dated effective September 1, 2013, LLOG Bluewater Holdings, L.L.C. (“**LBH**”), as Assignor, assigned an overriding royalty interest to Stork Holdings Corp. (“**Stork**”) as evidenced by that certain Assignment of Overriding Royalty Interest, recorded on August 28, 2015 in COB 1346, Page 815, under Instrument No. 2015-00003369, in the official records of Plaquemines Parish, Louisiana (the “**Assignment**”) and in the non-required files of the BOEM on September 16, 2015, affecting the following oil and gas lease:

Federal OCS Oil and Gas Lease bearing Lease No. OCS-G 34966, effective September 1, 2013 between the United States of America, as Lessor, and Ridgewood Energy Corporation, et al, as Lessee, covering all of Block 39, Green Canyon, OCS Official Protraction Diagram, NH 15-03, containing 5,760.0 acres, more or less.

WHEREAS, on or about July 27, 2018, OCS-G 34966 became a segregated lease as the result of an Assignment of Record Title Interest and the record title interest owned by ASSIGNEE was assigned to the newly segregated portion of the lease bearing lease number OCS-G 36331 (the “**Segregated Lease**”).

WHEREAS, by instrument dated effective April 1, 2018, Stork Holdings I LLC (“**Stork I**”), as Assignor, reconveyed a portion of its overriding royalty interest to LBH **INSOFAR AND ONLY INSOFAR AS to the E/2NW/4NE/4, NE/4SW/4NE/4 and S/2SE/4NE/4** of the Segregated Lease, as Assignee, as evidenced by that certain Partial Reconveyance of Overriding Royalty Interest, recorded on August 22, 2018, in COB 1401, Page 516, under Instrument No. 2018-00003095, in the official records of Plaquemines Parish, Louisiana and in the non-required files of BOEM on August 29, 2018 (the “**Reconveyance**”).

WHEREAS, although Apparer was a party to the Assignment, it was not a party to the Reconveyance.

WHEREAS, it is the intent of Appearer to ratify and confirm the Reconveyance and to put third parties on notice of this Ratification affecting interests in the Segregated Lease as outlined above.


NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Appearer does hereby and by these presents ratify and confirm the Reconveyance, to the same extent and with the same force and effect as if Appearer had joined in the execution of the Reconveyance as a party thereto, but not otherwise.

This Ratification shall be binding upon the Appearer hereto and upon its successors and assigns.




