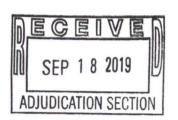

OIL WELL LIEN AFFIDAVIT, NOTICE OF CLAIM, AND STATEMENT OF PRIVILEGE

BEFORE ME, the undersigned authority, personally came and appeared the affiant:

DAVID CEDRO

who, after being duly sworn, did depose and say:

1.

Affiant is an authorized representative of **Danos**, **LLC** ("Danos"), 3878 West Main Street, Gray, Louisiana 70359. Affiant to duly authorized to make, and is making, this affidavit and statement of privilege and notice of claim of lien for and on behalf of Danos.

2.

Danos is in the business of furnishing labor, equipment, machinery, materials, and related services in support of the development, exploration, maintenance, operation, and abandonment of oil and gas well(s).

3.

On April 27, 2018, Danos contracted with Epic Companies, LLC ("Epic"), of 24955 Interstate 45 North, The Woodlands, Texas 77380, to provide various services in support of Epic's hydrocarbon exploration and production activities, and to provide products, equipment, goods, materials, supplies, or other deliverables in connection with the provision of such services (the "Contract").

4.

Beginning on or about April 27, 2018, and continuing through the present day, Danos provided labor, materials, and services to Epic in connection with the operation, including drilling, completing, testing, production, reworking, or abandoning of that certain Lease No. OCS-G-09627, Outer Continental Shelf, Ship Shoal Area, South Addition, Block 277, off the coast of Terrebonne Parish, State of Louisiana (the "Lease").

5.

As of the present date, a remaining principal amount of \$943,357.37 is due and owing on Invoice Nos. 154591, 154582, 154482, 155046, 155732, 155485, 155734, 155735, 155889, 156298, 156567, 156765, 157062, 157238, 157237, 157533, 159273, 159275, 159276, 160476, 159274, 158111, 159415, 164028, 174850, 174849, 174848, 174847, 174846, 154994, and INVEqRent (collectively, the "Invoices") for those certain goods, equipment, and services provided by Danos to the Lease, together with accruing interest, plus attorney fees and costs. A

spreadsheet detailing the amounts owed under each referenced Invoice is attached hereto as Exhibit A.

6.

At all relevant times hereto, the labor, equipment, supplies, and services provided by Danos were used for or in connection with the drilling, exploration, development, operation, and/or abandonment of the Lease.

7.

As evidenced by the records of the United States Department of the Interior, Bureau of Ocean Energy Management (the "BOEM"), Monforte Exploration, LLC, BOEM Company Number 2800, 2925 Richmond Avenue, Suite 1200, Houston Texas 77098, was at all relevant times and remains the operator of the above-referenced Lease with respects to all depths from the surface tom 7,350° TVD.

8.

This Affidavit is made for the purposes of securing payment of the debt owed by Epic to Danos as described herein and is made in accordance with La. R.S. 9:4861, et seq., and all other applicable laws for the purposes of preserving the liens and privileges granted by law to Danos on the following: (1) the Lease, and any wells located on the Lease; (2) the operating interest of the operator of the Lease, Monforte, and the operating interest of any participating lessee(s) therein, together with such parties interest in any (a) well(s), building, tank, leasehold pipeline, platforms, machinery, flowlines, gathering lines, and other related equipment and other construction or facility located thereon, (b) all movables used in the operation of the well attached thereto or located on the Lease and/or well site, including, but not limited to monitoring, measuring, metering, and control equipment, appurtenances, appliances, equipment, and other structures and (c) tract of land, servitude or other lease described in La. R.S. 9:4861(12)(c) covering the Lease; (3) drilling or other rig located at the Lease, if the rig is owned by the operators of the Lease, Monforte; (4) all hydrocarbons produced from the operating interest of the operators of the Lease, Monforte, and the operating interest of any participating lessee(s) therein; and (5) the proceeds received by, and the obligations owed to, any lessee or operating interest from the disposition of hydrocarbons subject to the privilege for the amount due for the labor, supplies, and services, in principal and interest, and for the cost of preparing and recording the privilege, or any notice of *lis pendens* and contractual or statutory attorneys' fees.

That this Affidavit, Notice of Claim, and Statement of Privilege is being filed in the Mortgage Records of Terrebonne Parish, State of Louisiana, and with the BOEM.
