

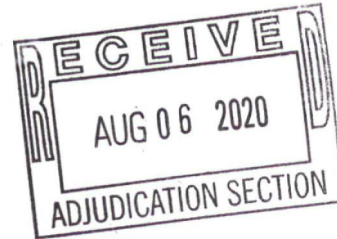

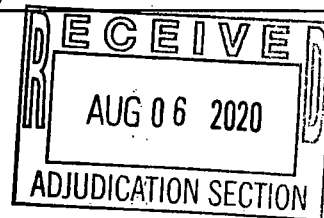

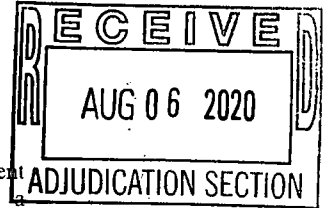

**PARTIAL RECONVEYANCE OF
OVERRIDING ROYALTY INTEREST,
RELEASE AND RELINQUISHMENT**



THIS Partial Reconveyance of Overriding Royalty Interest, Release and Relinquishment (herein called "Reconveyance") is made by **LLOG Deepwater Royalty Company, L.L.C.**, a Delaware limited liability company, whose address is 1001 Ochsner Boulevard, Suite 100, Covington, Louisiana 70433 ("Assignor") to **LLOG Exploration Offshore, L.L.C. ("LEO")**, a Louisiana limited liability company, whose address is 1001 Ochsner Boulevard, Suite 100, Covington, Louisiana 70433 and **LLOG Bluewater Holdings, L.L.C. ("LBH")**, a Delaware limited liability company, whose address is 1001 Ochsner Boulevard, Suite 100, Covington, Louisiana 70433 (collectively referred to as "Assignees").

WHEREAS, by Assignment of Overriding Royalty Interest dated effective July 1, 2014, filed in the non-required files of the Bureau of Ocean Energy Management on August 15, 2014, and recorded in the Plaquemines Parish, Louisiana Conveyance record on August 8, 2014, in Book 1323, beginning at Page 773, under File No.: 2014-00003236, in the Lafourche Parish, Louisiana Conveyance records on May 22, 2019, in Book 2136, beginning at Page 95, under File No. 1277405, and in the Jefferson Parish, Louisiana Conveyance records on June 18, 2019, in Book 3422, beginning at Page 693, under File No. 11928042, Assignees conveyed an overriding royalty interest (the "Overriding Royalty Interest") burdening the following Oil and Gas Lease (the "Subject Lease") to Assignor, to-wit:

Oil and Gas Lease of Submerged Lands, dated effective as of July 1, 2014, by and between the United States of America, as Lessor, and LLOG Bluewater Holdings, L.L.C., as Lessee, covering all of OCS-G 35295, Block 877, Ewing Bank, OCS Official Protraction Diagram, NH 15-12, containing 5,760.00 acres, more or less.

WHEREAS, Assignor desires that an undivided nine hundred three thousand sixty-six millionths percent (0.903066%) of 8/8ths interest in and to the Overriding Royalty Interest (the "Reconveyed ORRI") be reconveyed to Assignees and Assignees wish to acquire the Reconveyed ORRI in the following proportions:

LLOG Exploration Offshore, L.L.C.	1%
LLOG Bluewater Holdings, L.L.C.	99%

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor **HEREBY GRANTS, ASSIGNS, TRANSFERS, SELLS, AND CONVEYS** to Assignees, subject to the terms and conditions contained herein, the Reconveyed ORRI.

AS A RESULT, ASSIGNOR'S REMAINING OVERRIDING ROYALTY INTEREST IN AND TO THE SUBJECT LEASE WILL NOW BE AN UNDIVIDED SIX HUNDRED EIGHTY-FIVE THOUSAND EIGHT HUNDRED EIGHTY-FOUR MILLIONTHS PERCENT (0.685884%) OF 8/8THS INTEREST.

This Reconveyance shall be subject to the following terms and conditions, to-wit:

1. This Reconveyance shall be effective as of April 1, 2020 (the "Effective Date").
2. Assignor and Assignees acknowledge and agree that upon execution hereof, and as of the Effective Date, the Reconveyed ORRI will be merged with and into Assignees' working interest in and to the Subject Lease and shall be deemed ipso facto extinguished by merger and confusion, or other operation of law.

3. Assignor conveys the Reconveyed ORRI to Assignees without warranty of title, express, statutory or implied, except that Assignor will specially warrant and agree to defend title to the Reconveyed ORRI against the lawful claims and demands of all persons claiming title to the Overriding Royalty Interest by, through and under Assignor, but not otherwise.

TO HAVE AND TO HOLD UNTO Assignees, their successors and assigns, forever.






