ASSIGNMENT OF RECORD TITLE INTEREST IN FEDERAL OCS OIL AND GAS LEASES

THAT, this Act of Correction is executed by and between HEDV Khaleesi, LLC, a Texas limited liability company, and HEDV KLM, LLC, a Texas limited liability company. For the purposes of this Act, HEDV Khaleesi, LLC, and HEDV KLM, LLC may hereinafter be referred to individually as a "Party and collectively as the "Parties".

This Act may be executed in any number of counterparts, and each counterpart shall be deemed to be an original instrument, but all such counterparts shall constitute but one instrument and shall be binding on all Parties so executing regardless whether this Act or any counterpart thereof is executed by all the Parties.
