**ACT OF RELEASE, TERMINATION AND RELINQUISHMENT  
OF OVERRIDING ROYALTY INTERESTS**

THIS Act of Release, Termination and Relinquishment of Overriding Royalty Interests (herein called "Relinquishment") is dated effective as of August 12, 2019 (the "Effective Date") and is made by **Energy XXI M21K, LLC**, a Delaware limited liability company ("EXXI").

WHEREAS, by Assignment of Overriding Royalty Interest, executed August 11, 2015, effective as of July 1, 2015, filed in the various jurisdictions as shown on the attached *Exhibit A*, M21K, LLC ("M21K") conveyed to EXXI an overriding royalty interest equal to 20% of 8/8ths of the Net Revenue Interest owned by and attributable to M21K's Working Interest in and to each of the Leases, as such terms are defined therein (the "ORRI Assignment");

WHEREAS, the overriding royalty interests conveyed by the ORRI Assignment (the "ORRIs") were limited to a Term, as such term is defined in the ORRI Assignment, and such Term has expired; and

WHEREAS, EXXI now desires to release, terminate, relinquish and surrender all of the ORRIs.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and in order that the public records accurately reflect the intention of the party hereto, EXXI does hereby and by these presents RELEASE, TERMINATE, RELINQUISH and SURRENDER the ORRIs effective as of the Effective Date. By virtue of this Relinquishment, the ORRIs are extinguished and have no further force and effect upon the Leases.

This Relinquishment is executed hereto on December 19, 2022, but shall be effective for all purposes as of the Effective Date.
