

STATEMENT OF PRIVILEGE - LOUISIANA REVISED STATUTES 9:4861 ET SEQ.

BEFORE ME, the undersigned authority, on this day appeared William Marsh and stated on oath as follows:

1. My name is William Marsh. I am General Counsel and Vice President of Administration for Cactus Wellhead, LLC ("Cactus"). The mailing address of Cactus is 920 Memorial City Way, Suite 300, Houston, TX 77024. I have personal knowledge of the facts stated in this affidavit, which are true and correct, through my position with Cactus and am competent and authorized to make this affidavit on behalf of Cactus. Cactus is referred to in this affidavit as "Claimant."

2. Claimant provided services to Cox Operating, LLC ("Cox Operating") in connection with an oil and/or gas well on the property (the "Well Site") described as:

Area: South Marsh Island
Block: 288
Adjacent Parish: Iberia, Louisiana

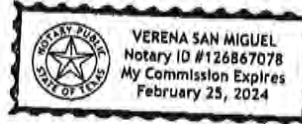
