STATEMENT OF LIEN AND PRIVILEGE PURSUANT TO
CHAPTER 56 OF THE TEXAS PROPERTY CODE AND
LOUISIANA REVISED STATUTES § 9:4861, ET SEQ.

BEFORE ME, the undersigned Notary, personally came and appeared:

POSEIDON TECHNOLOGY L.L.C., a Louisiana limited liability company, represented herein by its duly authorized Manager, Bernadette Alaniz,

who, after being duly sworn, did declare and acknowledge the following:

1. Poseidon Technology L.L.C. ("Poseidon") asserts this lien and privilege claim pursuant to the provisions of Chapter 56 of the Texas Property Code and the Louisiana Oil Well Lien Act, Louisiana Revised Statutes § 9:4861, *et seq.* The domicile address of Poseidon is 124 Stafford Place, New Orleans, LA 70124 and the mailing address of Poseidon is 2117 Veterans Blvd, Metairie, Louisiana 70002.
2. The obligation claimed by Poseidon is in the amount of **\$5,516.83**, together with legal interest, the cost of preparing and filing this lien and privilege, and attorneys' fees.
3. The amount described in the preceding paragraph is owed to Poseidon by **Gulf Offshore LLC** ("Gulf Offshore"), a Delaware limited liability company, whose registered agent for service of process in Louisiana is Lee Lemaire, 7209 Lake Penegneur, New Iberia, Louisiana 70560. Upon information and belief, the domicile and/or mailing address for Gulf Offshore is 4400 Post Oak Pkwy, Suite 2535, Houston TX 77027. Neither Gulf Offshore nor any other person has paid this outstanding amount as of the date of this Statement of Lien and Privilege.
4. The obligations of Poseidon and Gulf Offshore are governed by that certain unrecorded Master Service Agreement dated July 16, 2025. Under the Master Service Agreement, the laws of Texas apply to any dispute between Poseidon and Gulf Offshore. Accordingly, the Statement of Lien and Privilege complies with Texas law. Nevertheless, out of an abundance of caution, the Statement of Lien and Privilege also complies with Louisiana law to the extent that it applies.
5. Poseidon furnished labor, services, equipment, materials, and supplies to Gulf Offshore for use in connection with the operation of oil and gas wells and operations that are described in greater detail below. Those operations include the search for or production of oil or gas in connection with certain related oil, gas, or mineral leases. The labor, services, equipment, materials, and supplies performed and furnished by Poseidon include, without limitation, the rental of upright acid tanks and tote tanks and the sale of chemicals and associated supplies to be used at the well sites and/or production platforms that are more fully described on Exhibit "A," attached hereto.
6. Upon information and belief, Gulf Offshore and/or TOPCO Offshore, LLC is the operator of the wells and/or production blocks described herein. Gulf Offshore placed the order for the labor, services, equipment, materials, and supplies described above and received delivery thereof in its capacity as operator.
7. Attached hereto as Exhibit "B" is the balance sheet summarizing Gulf Offshore's principal balance and interest as of November 6, 2025, for the labor, services, equipment, materials, and supplies performed and furnished by Poseidon. Attached hereto as Exhibit "C" are photocopies of the unpaid invoices for the labor, services, equipment, materials, and supplies performed and furnished by Poseidon.
8. This Statement of Lien and Privilege is made for the purpose of preserving the lien of Poseidon pursuant to the provisions of Chapter 56 of the Texas Property Code and the Louisiana Oil Well Lien Act, Louisiana Revised Statutes § 9:4861, *et seq.* (particularly, Louisiana Revised Statutes § 9:4862), and is intended to preserve such lien claims on all tangible or intangible property as set forth in Section 56.003 of the Texas Property Code (Texas Codes Annotated) and Louisiana Revised Statutes § 9:4863 along with the
