This Assignment and Bill of Sale (this "Assignment") is executed between **HE&D Offshore, L.P.**, a Texas limited partnership, whose address is 1200 Smith Street, Suite 2400, Houston, Texas 77002 ("Assignor"), and **HEDV Daenerys, LLC**, a Texas limited liability company, whose address is 1200 Smith Street, Suite 2400, Houston, Texas 77002 ("Assignee"). Assignor and Assignee may hereinafter be referred to individually as a "Party" and collectively as the "Parties."

**RECITALS**

**WHEREAS**, reference is hereby made to the following oil and gas leases (hereinafter referred to individually as a "Lease" and collectively as the "Leases");

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, effective August 1, 2016, bearing Serial Number OCS-G 35894, granted by the United States of America, as Lessor, in favor of Houston Energy, L.P. and Red Willow Offshore, LLC, as Lessees, covering all of Block 106, Walker Ridge, OCS Official Protraction Diagram, NG 15-06, containing approximately 5,760 acres ("WR 106 Lease");

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, effective August 1, 2015, bearing Serial Number OCS-G 35724, granted by the United States of America, as Lessor, in favor of Houston Energy, L.P. and Red Willow Offshore, LLC, as Lessees, covering all of Block 107, Walker Ridge, OCS Official Protraction Diagram, NG 15-06, containing approximately 5,760 acres ("WR 107 Lease");

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, effective August 1, 2016, bearing Serial Number OCS-G 35895, granted by the United States of America, as Lessor, in favor of Houston Energy, L.P. and Red Willow Offshore, LLC, as Lessees, covering all of Block 150, Walker Ridge, OCS Official Protraction Diagram, NG 15-06, containing approximately 5,760 acres ("WR 150 Lease"); and

Oil and Gas Lease of Submerged Lands under the Outer Continental Shelf Lands Act, effective August 1, 2020, bearing Serial Number OCS-G 36926, granted by the United States of America, as Lessor, in favor of Houston Energy, L.P. and Red Willow Offshore, LLC, as Lessees, covering all of Block 151, Walker Ridge, OCS Official Protraction Diagram, NG 15-06, containing approximately 5,760 acres ("WR 151 Lease").

WHEREAS, pursuant to the assignments listed on *Exhibit A* attached hereto (hereinafter referred to individually as a “Prior Assignment” and collectively the “Prior Assignments”), the obligation to convey to Assignor certain carried working interests in and to the each Lease was acknowledged by the record title owners of such Leases; and

WHEREAS, Assignor desires to assign, and Assignee desires to acquire, all of Assignor’s right, title and interest in and to each “Carried Interest” (as such term is defined in each Prior Assignment) that burdens the Leases.

NOW, THEREFORE, for and in consideration of One Hundred Dollars (\$100.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby **ASSIGN, BARGAIN, SELL, TRANSFER, SET-OVER, GRANT, CONVEY AND DELIVER** unto Assignee, and Assignee hereby accepts from Assignor, effective as the Effective Time, all of Assignor’s right, title and interest in and to each Carried Interest burdening the respective Lease (collectively, the “Assigned Interests”).

**TO HAVE AND TO HOLD** the Assigned Interests unto Assignee, its successors and assigns forever, provided, however, subject to all the terms and conditions of this Assignment.

This Assignment is made and accepted without warranty of title, express or implied, except as to persons lawfully claiming by, through or under Assignor, but not otherwise, provided Assignee shall have the right of full substitution and subrogation in and to any and all rights and actions of warranty which Assignor has or may have against all preceding owners of the Assigned Interests.

This Assignment shall be effective for all purposes as of August 1, 2025, at 7:00 a.m. local time where the Leases are located (“Effective Time”).

This Assignment shall inure to the benefit of and be binding upon the respective successors and assigns of the Parties hereto.

THIS ASSIGNMENT SHALL BE GOVERNED, CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS, EXCLUDING ANY CONFLICTS-OF-LAW RULE OR PRINCIPLE THAT MIGHT APPLY THE LAW OF ANOTHER JURISDICTION.

This Assignment may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all of such counterparts shall constitute for all purposes one agreement.




