ASSIGNMENT OF OVERRIDING ROYALTY INTERESTS

UNITED STATES OF AMERICA

OUTER CONTINENTAL SHELF

This Assignment of Overriding Royalty Interests (the "Assignment") dated as of July 9, 2026 (the "Execution Date"), but effective as of 12:00 a.m. local time at the location of the Conveyed Assets on June 1, 2026 (the "Effective Time") is executed by **ECP GOM ORRI I, LLC**, a Delaware limited liability company, whose address is 11 Greenway Plaza, Suite 2010, Houston, Texas 77046 ("Assignor"), in favor of **Penroc Oil Corporation**, a Texas corporation, whose address is PO Box 2769, Hobbs, NM 88241 ("Assignee"). Assignor and Assignee may be referred to herein together as the "Parties" and, each individually as a "Party".

WHEREAS, Assignor holds certain overriding royalty interests in the oil and gas leases described on Exhibit A hereto and desires to sell, transfer, assign and convey to Assignee, and Assignee desires to purchase, acquire and accept from Assignor, Assignor's right, title and interest in, to, and under the Conveyed Assets and the Assumed Obligations.

NOW, THEREFORE, in consideration of the sum of One Hundred Dollars (\$100.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, in consideration of the premises and covenants hereinafter contained, and in consideration of the representations, warranties and covenants contained in the Purchase Agreement, the Parties hereto desire to enter into this Assignment on the terms set forth herein.

1. Definitions

Capitalized terms used but not otherwise defined in this Assignment shall have the meaning given to such terms in that certain Purchase Agreement between Assignor and Assignee dated July 9, 2026, as amended, modified or supplemented from time to time in accordance with its terms (the "Purchase Agreement").

2. Assignment of Conveyed Assets

Subject to the terms set forth herein and upon the terms and subject to the conditions of the Purchase Agreement, Assignor does hereby **GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER, AND DELIVER** unto Assignee and its successors and assigns, and Assignee does hereby accept and acquire from Assignor, all of Assignor's right, title and interest in, to, and under the following, without duplication, except, in each case, to the extent constituting Excluded Assets (collectively, the "Conveyed Assets"):

- (a) any overriding royalty interests pertaining to the oil and gas leases listed on Exhibit A (the "Leases"), including the overriding royalty interests set forth on Exhibit B attached hereto, but in each case solely to the extent pertaining to the Leases (the "ORRIs");
- (b) all proceeds, revenues, or other benefits attributable to production from or attributable to the ORRIs or the ownership of the ORRIs, in each case, attributable to periods from and after the Effective Time;

- (c) all rights, claims and causes of action relating to the ownership of the ORRIs, in each case, attributable to (i) periods from and after the Effective Time, or (ii) any of the Assumed Obligations;
- (d) all agreements and instruments, if any, to the extent same relate to the ORRIs; and
- (e) the Records.

SAVING, EXCEPTING AND RESERVING to Assignor, however, all of the following assets (the "Excluded Assets"): (a) all corporate, financial, income and franchise tax and legal records of Assignor that relate to Assignor's business generally, and all books, records and files that relate to the Excluded Assets; (b) all geological and geophysical data (including seismic data) and, to the extent not expressly included in the Records, all interpretive data, technical evaluations, reserve estimates and economic estimates; (c) all rights to any refund of taxes or other costs or expenses attributable to periods prior to the Effective Time; (d) Assignor's area-wide bonds, permits and licenses or other authorizations used in the conduct of Assignor's business generally; (e) all trade credits, account receivables, and other receivables attributable to the Conveyed Assets with respect to any period prior to the Effective Time; and (f) any working interest, net profits interest, or other cost-bearing interest in the Leases.

In the event Assignee holds a working interest in any of the Leases, it is the intent of the parties hereto that the legal concept of confusion or merger shall not apply to the ORRI assigned herein and the ORRI assigned herein shall continue to burden the working interest held by Assignee in such Lease.

TO HAVE AND TO HOLD all and singular the Conveyed Assets together with all rights, titles, interests, estates, remedies, powers, privileges and appurtenances thereunto, unto Assignee and its successors and assigns, forever, subject to the terms, covenants and conditions set forth herein and in the Purchase Agreement.

3. Assignment and Assumption of Assumed Obligations

Upon the terms and subject to the conditions of the Purchase Agreement, Assignee hereby assumes, shall be responsible for, and shall pay and discharge all of the Assumed Obligations. From and after the Retained Obligations period in the Purchase Agreement, Assignee shall further assume, be responsible for, and pay and discharge all obligations and liabilities constituting Retained Obligations, which shall thereupon be deemed to constitute Assumed Obligations for all purposes, regardless of whether such obligations and liabilities arose prior to, on, or after the Effective Time, all as more particularly set forth in the Purchase Agreement.

4. Subrogation

Assignee is hereby specifically assigned, and subrogated to, all warranties of title which Assignor or its affiliates may have from predecessors in interest to the extent applicable with respect to the Conveyed Assets and to the extent Assignor or such affiliates may legally assign such rights and grant such subrogation.

5. Successors and Assigns

This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, successors, assigns and transferees.

7. Purchase Agreement

The respective rights of Assignor and the Assignee with respect to the Conveyed Assets sold, conveyed, assigned, transferred and delivered hereby and the Assumed Obligations assumed hereby shall be governed exclusively by the Purchase Agreement, and nothing in this Assignment shall alter any right, liability or obligation arising under the Purchase Agreement, which shall (without limiting the generality of the foregoing) govern, and shall contain the sole and exclusive representations, warranties and obligations of the Parties with respect to such Conveyed Assets and such Assumed Obligations. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall prevail and apply.

8. Exhibits

All of the Exhibits referred to in this Assignment are hereby incorporated into this Assignment by reference and constitute a part of this Assignment.

9. Interpretation

Except as expressly provided herein to the contrary, the following provisions of the Purchase Agreement shall apply mutatis mutandis to this Assignment as if they were expressly set forth herein: the waiver, governing law, venue, jury trial waiver, counterparts, amendments, severability, and disclaimer provisions of Section 16 of the Purchase Agreement.

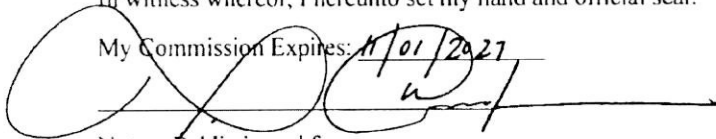

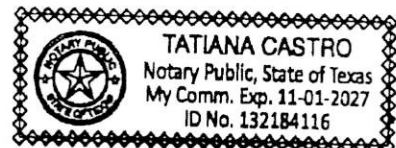
