Your letter dated March 1, 2023, submitting replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. GM216860, in the amount of \$1,212,300, was received by our office on March 2, 2023. This bond, conditioned to cover Right-of-Way OCS-G 17749, was executed on March 1, 2023, with Empire Deepwater LLC as principal and Great Midwest Insurance Company as surety.

This bond replaces Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. B010489, in the amount of \$1,212,300. This bond, conditioned to cover Right-of-Way OCS-G 17749, was executed on March 1, 2017, with Empire Deepwater LLC as principal, and U.S. Specialty Insurance Company as surety.

The replacement bond, Bond No. GM216860, conforms to the requirements of the leasing and operating regulations for submerged lands of the Outer Continental Shelf and is considered to be effective March 1, 2023, the date it was executed. The period of liability of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. B010489 is considered to have terminated and the bond is considered cancelled without residual liability on the same date.


