Your letter dated April 1, 2023, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0035066, in the amount of \$690,000, was received by our office on May 2, 2023. This bond, conditioned to cover Right-of-Way OCS-G 1856A, was executed on February 26, 2016, with Targa Midstream Services Limited Partnership as principal and Argonaut Insurance Company as surety.

Targa Midstream Services LLC ("Targa Midstream") (GOM 2340) submitted the following bond, dated as of February 26, 2016, effective March 9, 2016, to the Bureau of Ocean Energy Management "BOEM" to cover OCS-G 01856A:

1. Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond by Argonaut Insurance Company, as Surety and Targa Midstream Services LLC, as Principal, bearing Bond No. SUR0035066 covering OCS-G 01856A, in the amount of \$690,000.00, and any riders associated there with, hereinafter referred to as the "Original Bond".

Targa Midstream requests cancellation of the Original Bond because it is assigning all of its interest in the referenced right of way (OCS-G 01856A) to Targa LA Operating LLC ("Targa LA Operating").

Targa LA Operating has acquired and filed under separate cover letter, the following New Replacement Bond.

2. Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond by Argonaut Insurance Company, as Surety and Targa LA Operating LLC, as Principal, bearing Bond No. SUR0076735, in the amount of \$690,000.00 dated the March 14, 2023, hereinafter referred to as the "New Replacement Bond". This bond replaces and supersedes Bond SUR0035066. This bond hereinafter referred to as the "New Replacement Bond."

Since the New Replacement Bond covers "All Obligations of all previous Sureties or guarantors even if the Obligations are not Obligations of the Principal during the period of liability of this bond" Targa Midstream requests that the above referenced Original Bond be fully released and canceled.

Once you have reviewed and approved the New Replacement Bond, please mark cancelled on the Original Bond and send a letter to me acknowledging the cancellation of the Original Bond.


