Your letter dated June 13, 2023, submitting Decrease Bond Rider, to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SBP150014_011, in the amount of \$548,591, was received by our office on that same date.
