Your letter dated June 12, 2023, submitting Decrease Bond Rider, to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SBP150014_006, in the amount of \$1,895,000, was received by our office on that same date.
