Your letter dated June 12, 2023, submitting Decrease Bond Rider, to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SBP150014_013, in the amount of \$1,745,000, was received by our office on that same date. The purpose of pipeline ROW OCS-G12729 is to maintain and operate PSN 9348 and to transport gas from Platform A in Block 109 to a 12-inch subsea tie-in with PSN 14970, at X=1,004,647.90 and Y=10,481,825.00, in Block 108, all located in Mississippi Canyon Area.

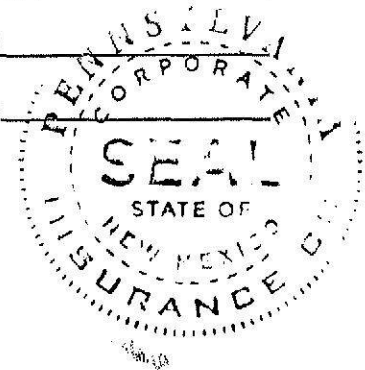

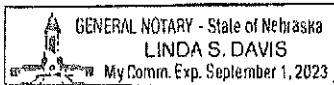

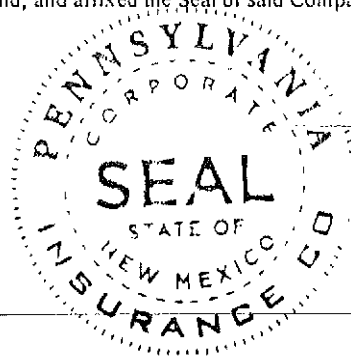
