Dear Mr. Krenek:

Your letter dated August 21, 2025, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. N-7000941, in the amount of \$950,000, was received by our office on August 26, 2025. This bond, conditioned to cover Right-of-Way OCS-G 29055, was executed on March 23, 2018, with Northstar Offshore Ventures LLC as principal and Indemnity National Insurance Company as surety.

Attached to and forming a part of Bond No. N-7000941, is Name Change Bond Rider, executed on February 4, 2019, which changes the name of the principal from Northstar Offshore Ventures LLC to Sanare Energy Partners, LLC. The rider is effective November 29, 2018.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 29055 to be \$0. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. N-7000941, which is considered cancelled without residual liability effective August 27, 2025, the date of final concurrence with the cancellation.
