Your letter dated August 24, 2018, submitting your Increase/Decrease Rider OCS-G 1506, to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0032495 in the amount of \$695,000 was received by our office on August 27, 2018. This bond, conditioned to cover Right-of-Way OCS-G 1506, was executed on June 30, 2015, with Grand Isle Corridor, LP as principal and Argonaut Insurance Company as surety.


