Your letter dated July 17, 2018, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. B009203, in the amount of \$550,000 was received by our office on July 18, 2018. This bond, conditioned to cover Right-of-Way OCS-G 14273, was executed on February 6, 2015, with Fieldwood Energy LLC as principal and U.S. Specialty Insurance Company as surety.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability to be \$0 for G14273. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. B009203, which is considered cancelled without residual liability effective September 4, 2018, the date of final concurrence with the cancellation.

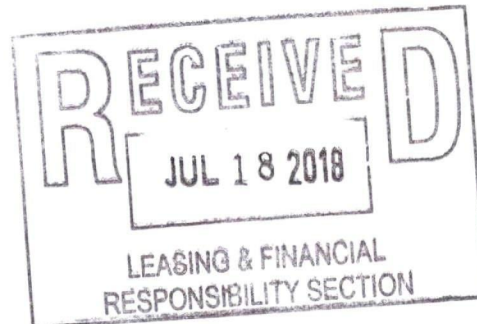
