Dear Mr. Coates:

Your letter dated October 9, 2018, submitting your replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. 180103, in the amount of \$200,000 was received by our office on October 12, 2018. This bond, conditioned to cover Right-of-Way OCS-G 26933, was executed on July 5, 2018, with Whitney Oil & Gas, LLC as principal and Evergreen National Indemnity Company as surety.

This bond replaces your Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. RLB0016460 in the amount of \$100,000. This bond, conditioned to cover Right-of-Way OCS-G 26933, was executed on May 2, 2016, with Whitney Oil & Gas, LLC as principal, and RLI Insurance Company as surety.

Attached to and forming a part of Bond No. RLB0016460 is Rider No. 1, executed on September 20, 2016, which increases the amount of this bond by \$100,000 for a total penal sum of \$200,000. The rider is effective September 20, 2016.

The replacement bond, Bond No. 180103, conforms to the requirements of the leasing and operating regulations for submerged lands of the Outer Continental Shelf and is considered to be effective July 5, 2018, the date it was executed. The period of liability of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. RLB0016460 is considered to have terminated and the bond is considered cancelled without residual liability on the same date.




