Your letter dated December 14, 2018, submitting your replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. 1074995, in the amount of \$573,000, was received by our office on December 17, 2018. This bond, conditioned to cover Right-of-Way OCS-G 28215, was executed on December 6, 2018, with M21K, LLC as principal and The Hanover Insurance Company as surety.

This bond replaces your Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. K09277572, in the amount of \$1,195,000. This bond, conditioned to cover Right-of-Way OCS-G 28215, was executed on July 22, 2015, with M21K, LLC as principal, and Westchester Fire Insurance Company as surety.

Attached to and forming a part of Bond No. K09277572, is Decrease Bond Rider, executed on February 16, 2017, which decreases the bond by \$622,000 for a total penal sum of \$573,000. The rider is effective February 16, 2017.

The replacement bond, Bond No. 1074995, conforms to the requirements of the leasing and operating regulations for submerged lands of the Outer Continental Shelf and is considered to be effective December 6, 2018, the date it was executed. The period of liability of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. K09277572 is considered to have terminated and the bond is considered cancelled without residual liability on the same date.
