Your letter dated February 25, 2019, submitting Name Change Bond Rider, Bond Rider No. 2, to be attached to and form a part of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. RLB0016695 in the amount of \$5,386,754, was received by our office on February 27, 2019. This bond, conditioned to cover Right-of-Way OCS-G 29341, was executed on January 6, 2017, with Deep Gulf Energy III, LLC as principal and RLI Insurance Company as surety.


