Dear Mr. Schulte:

Your letter dated May 22, 2019, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. **SUR0032502**, in the amount of \$1,895,000, was received by our office on May 23, 2019. This bond, conditioned to cover Right-of-Way OCS-G 5229, was executed on June 30, 2015, with Grand Isle Corridor, LP as principal and Argonaut Insurance Company as surety.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 5229 to be \$0. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. SUR0032502, which is considered cancelled without residual liability effective May 31, 2019, the date of final concurrence with the cancellation.

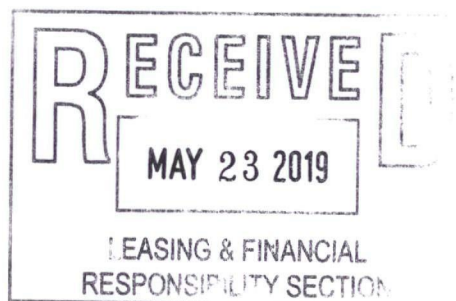
