Your letter dated July 18, 2019, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Pipeline Right-of-Way Grant Bond No. N-7001165, in the amount of \$250,000, was received by our office on July 22, 2019. This bond, conditioned to cover Right-of-Way OCS-G 15677, was executed on August 16, 2018, with Northstar Offshore Ventures LLC as principal and Indemnity National Insurance Company as surety.
