Dear Mr. Daughdrill:

Your letter dated August 16, 2019, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. **SUR0038075**, in the amount of \$463,116, was received by our office on August 19, 2019. This bond, conditioned to cover Right-of-Way OCS-G 11684, was executed on June 8, 2018, with Avocet LNG, LLC as principal and Argonaut Insurance Company as surety.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 11684 to be \$0. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. SUR0038075, which is considered cancelled without residual liability effective August 26, 2019, the date of final concurrence with the cancellation.

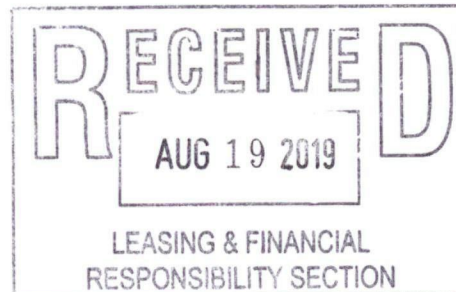

Avocet LNG, LLC (Avocet) requests that the Bureau of Ocean Energy Management (BOEM) cancel bond number SUR0038075 in the amount of \$463,116 covering the abandonment of pipeline Right-of-Way (ROW) OCS-G11684. A copy of this bond is attached for your information and summarized below:

By way of background, please note that Avocet received authorization from the Bureau of Safety and Environmental Enforcement (BSEE) on May 20, 2019 to abandon Pipeline Segment Number (PSN) 8827 in place and relinquish pipeline ROW OCS-G11684. In late May and early June 2019, Avocet performed the approved decommissioning procedures on PSN 8827 and abandoned the pipeline in place. In a letter dated July 10, 2019, Avocet submitted our Abandonment/Decommissioning Completion Report to BSEE's Pipeline Section in New Orleans, Louisiana. Our Abandonment Completion Report was accepted by the BSEE Pipeline Section on August 13, 2019.

Since we have decommissioned PSN 8827 and relinquished pipeline ROW OCS-G11684, Avocet LNG, LLC respectfully requests that BOEM cancel Supplemental bond number SUR0038075 at your earliest convenience.
