Dear Mr. Cizek:

Your letter dated August 19, 2019, requesting cancellation of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. 022054120, in the amount of \$850,000, was received by our office on August 20, 2019. This bond, conditioned to cover Right-of-Way OCS-G 11186, was executed on January 13, 2016, with HI-BOL Pipeline LLC as principal and Liberty Mutual Insurance Company as surety.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 11186 to be \$0. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. 022054120, which is considered cancelled without residual liability effective August 27, 2019, the date of final concurrence with the cancellation.
