
Dear Mr. Dorey:

Your letter dated August 27, 2018, submitting Bond Rider To Assume Liability, Rider No. 3, to be attached to and form a part of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. SUR0015319, in the amount of \$300,000, was received by our office on August 29, 2019. This bond, conditioned to cover principal's pipeline operations in the Gulf of Mexico, was executed on March 25, 2019, with High Point Gas Gathering, L.L.C. as principal and Argonaut Insurance Company as surety.

With the acceptance of Rider No. 3, executed on August 26, 2019, Bond No. SUR0015319 extends to and covers all liability associated with Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. **SUR0000561**, in the amount of \$300,000. Therefore, the period of liability of Bond No. SUR0000561 is now considered terminated and the bond is cancelled without residual liability effective August 1, 2018, the effective date of Rider No. 3.

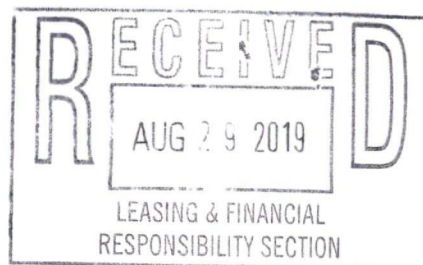



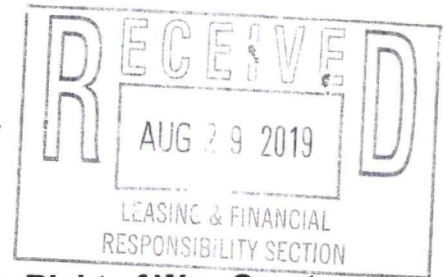
