

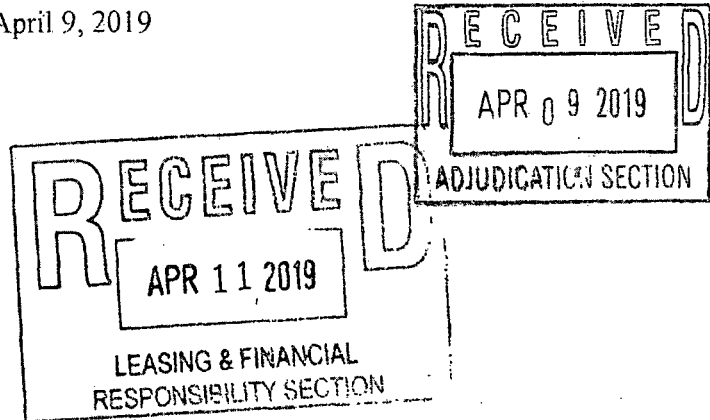

EPL Oil & Gas, Inc. (GOM No. 2266) seeks to update its qualification with BOEM to reflect its conversion from a Delaware corporation to a Delaware limited liability company named EPL Oil & Gas, LLC (the "**Company**"), effective December 31, 2018. 

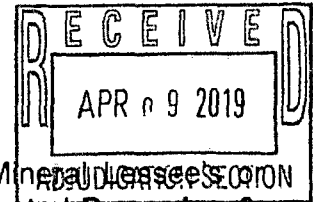


That this power is made and executed pursuant to the authority of the following Resolutions passed by the Board of Directors of said Company, and said Resolutions remain in full force and effect:
