Your letter dated May 26, 2020, submitting the Decrease Bond Rider to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SU1138036, in the amount of \$1,200,000, was received by our office on June 2, 2020.
