Your letter dated May 26, 2020, submitting the Decrease Bond Rider to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SU1139652, in the amount of \$565,000, was received by our office on June 2, 2020. This bond, conditioned to cover Right-of-Way OCS-G 28632, was executed on April 15, 2016, with American Panther, LLC as principal and Arch Insurance Company as surety.


