Dear Mr. DeBoer:

Your letter dated August 4, 2020, requesting cancellation of liability of Outer Continental Shelf (OCS) Mineral Lessee's and Operator's Bond No. RLB0009694, in the amount of \$50,000, was received by our office on August 5, 2020. This bond, conditioned to cover Lease OCS-G 30660, all of Block 98, High Island Area, was executed on September 27, 2006, with Whiting Oil and Gas Corporation as principal and RLI Insurance Company as surety.

Pursuant to 30 CFR 556.906 (d)(1) your bond may be cancelled seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligation, whichever is the latest. The period of liability of Bond RLB0009694 was terminated April 30, 2013.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. RLB0009694 is considered cancelled without residual liability, effective August 14, 2020, the date of final concurrence with such cancellation.
