Your letter dated September 24, 2020, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. EACX084000050, in the amount of \$160,000, was received by our office on that same date. This bond, conditioned to cover Right-of-Use and Easement OCS-G 30297, was executed on June 25, 2018, with Talos Energy Offshore LLC as principal and Endurance Assurance Corporation as surety.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 30297 to be \$0.
