Dear Mr. Brunasso:

Your letter dated April 7, 2021, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. K09201646, in the amount of \$995,000, was received by our office on April 8, 2021. This bond, conditioned to cover Right-of-Way OCS-G 24682, was executed on February 12, 2016, with Manta Ray Offshore Gathering Company, L.L.C. as principal and Westchester Fire Insurance Company as surety.

Attached to and forming a part of Bond No. K09201646, is Bond Rider No. 1, executed on January 31, 2017, which decreases the bond amount by \$422,084 for a total penal sum of \$572,916. The rider is effective January 31, 2017.

The Bureau of Safety and Environmental Enforcement has assessed the decommissioning liability for OCS-G 24682 to be \$0. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. K09201646, which is considered cancelled without residual liability effective April 19, 2021, the date of final concurrence with the cancellation.

Manta Ray Offshore Gathering Company, L.L.C. (GOM No. 21620

Manta Ray Offshore Gathering Company, L.L.C. ("MROG") hereby requests that the Bureau of Ocean and Energy Management ("BOEM") cancel MROG's bond associated with Right-of-Way OCS-G24682 for MROG's pipeline Segment 14161. MROG is qualified with BOEM to hold right-of-way grants and right-of-use and easement grants on the Outer Continental Shelf in the Gulf of Mexico under the assigned GOM Company No. 02162. On November 6, 2017 and amended submittals dated May 23, 2018 and June 6, 2018, MROG notified the Bureau of Safety and Environmental Enforce ("BSEE") that on July 5, 2019 it had completed the decommissioning in place of pipeline segment 14161, in compliance with the terms of a permit received **approval** from BSEE dated June 6, 2018.
