Your letter dated October 24, 2022, requesting termination and cancellation of Outer Continental Shelf Right-of-Way Grant Bond No. B06225, in the amount of \$300,000, was received by our office on that same date. This bond, conditioned to cover the principal's pipeline operations in the Gulf of Mexico, was executed on October 3, 1996, with Petrobras America Inc. as principal and Planet Indemnity Company as surety.

We are unable to grant your request at this time due to the following.
