Reference is made to your request dated November 28, 2017, with supplemental data submitted on March 27, 2018 and April 5, 2018, to modify Pipeline Right-of-way (ROW) OCS-G23429 to install a new bridge connected platform E-AUX which has been assigned the Complex ID No. 1093-2.

For ease of reference, PSN 13633 is described as follows:

Pursuant to 30 CFR 250.1000(b), your platform approval letter dated July 24, 2018, and your New Orleans District Approval dated August 21, 2018, your application is hereby approved.

The Right-of-way No. OCS- G23429 is updated as follows:

Pipeline Right-of-way (ROW) OCS- G23429 is a 200 foot wide and approximately 70.64 miles (372,942') long corridor associated with the 24 to 28-inch Pipeline Segment Number (PSN) 13633. The purpose of pipeline ROW OCS- G23429 is to maintain and operate Pipeline ROW accessory structures Platform E (Complex ID 1093-1), Platform E-AUX (Complex ID 1093-2), and PSN 13633 and to transport oil originating at Platform A in Mississippi Canyon Area Block 778 , through Mississippi Canyon Area Blocks 777, 733, 734, 690, 689, 645, 644, 643, 599, 598, 554, 553, 552, 508, 507, 463, 462, 418, 417, 416, 372, 371, 327, 326, 282, 281, 280, 279, and 278, through South Pass Area Blocks 91, 90, and terminating at Platform E in Block 89.
