Reference is made to LLOG Exploration Offshore, LLC's (LLOG) Right-of-way (ROW) pipeline installation application dated October 2, 2017 and received by this office on October 3, 2017 for Pipeline Segment Number (PSN) 19757. This application was amended with supplemental data via letter dated September 12, 2018 and received by this office on September 14, 2018.

Specifically, LLOG requests to install, operate, and maintain the following:

In accordance with 30 CFR 250.141, an alternate compliance is requested from 30 CFR 250.1002(a).

In accordance with 30 CFR 250.141, an alternate compliance is requested from 30 CFR 250.1002(c).

In accordance with 30 CFR 250.141, an alternate compliance is requested from 30 CFR 250.1003(b)(1).

Pursuant to 30 CFR 250.1000(b), your application is hereby approved.

The data provided in the application establishes the assigned maximum allowable operating pressure (MAOP) for the pipeline:

The assigned ROW number is OCS-G28775 and the ROW is described as follows:

"Pipeline Right-of-way (ROW) OCS-G 28775 is a 200-foot wide and approximately 5.14 miles (27,153 feet) long corridor associated with the 8-inch Pipeline Segment No. (PSN) 19757. The purpose of pipeline ROW OCS-G 28775 is to install, maintain, and operate PSN 19757 and to transport bulk oil from accessory South Manifold at X= 1,930,569.29' and Y= 9,501,615.34' in Block 829 through Blocks 830 and 874 to Platform A in Block 875, all in Keathley Canyon."

Pursuant to 30 CFR 250.141, your request for an alternate compliance from 30 CFR 250.1002(a) for is hereby approved. This office acknowledges that PSN 19757 will comply with the related requirements of API RP 1111.

Pursuant to 30 CFR 250.141, your request for an alternate compliance from 30 CFR 250.1002(c) for is hereby approved. This office acknowledges that PSN 19757 will comply with the related requirements of API RP 1111.

Pursuant to 30 CFR 250.141, your request for an alternate compliance from 30 CFR 250.1003(b)(1) is hereby approved. This office acknowledges that the flowline jumper will be pressure tested at 16,875 psi for four (4) hours onshore and leak tested by ROV post installation.

As a reminder, pursuant to 30 CFR 250.1008(a), you must notify the Regional Supervisor at least 48 hours prior to commencing the installation or relocation of a pipeline or conducting a pressure test on the pipeline. Commencement notifications should be emailed to pipelines@bsee.gov or faxed to (504) 736-2408.

As a reminder, pursuant to 30 CFR 250.1008(b), you are reminded to submit a report to the Regional Supervisor within 90 days after completion of any pipeline construction.

As a reminder, in accordance with a Letter to Lessees dated April 18, 1991, a copy of the as-built plats must be submitted to the NOAA-National Ocean Service-OCS, Chief, Nautical Data Branch, N/CS26, 1315 East West Highway, Silver Spring, MD, 20910-3282.
