Reference is made to LLOG Exploration Offshore, LLC's (LLOG) Right-of-way (ROW) pipeline installation application dated September 14, 2018 and received by this office on September 18, 2018 for Pipeline Segment Numbers (PSN) 19964, 20014, 20015, and 20016. This application was amended with supplemental data via email dated and received by this office on October 24, 2018.

Specifically, LLOG requests to install, operate, and maintain the following:

Pursuant to 30 CFR 250.1000(b), your application is hereby approved.

The data provided in the application establishes the assigned maximum allowable operating pressure (MAOP) for the pipeline:

The assigned ROW number is OCS-G28784 and the ROW is described as follows:

“Pipeline Right-of-way (ROW) OCS-G 28784 is a 200-foot wide and approximately 11.08 miles (58,492-feet) long corridor associated with a 5-inch umbilical (PSN 20014), a 2-inch umbilical (PSN 20015), and a 2-inch umbilical (PSN 20016). The purpose of pipeline ROW OCS-G 28784 is to install, maintain, and operate PSN 19964 and to transport bulk oil from an accessory PLEM in Block 999, through Blocks 1000, 956; 957, to Platform A in Block 956, all located in Viosca Knoll Area.”

As a reminder, pursuant to 30 CFR 250.1008(a), you must notify the Regional Supervisor at least 48 hours prior to commencing the installation or relocation of a pipeline or conducting a pressure test on the pipeline. Commencement notifications should be emailed to pipelines@bsee.gov or faxed to (504) 736-2408.

As a reminder, pursuant to 30 CFR 250.1008(b), you are reminded to submit a report to the Regional Supervisor within 90 days after completion of any pipeline construction.

As a reminder, in accordance with a Letter to Lessees dated April 18, 1991, a copy of the as-built plats must be submitted to the NOAA-National Ocean Service-OCS, Chief, Nautical Data Branch, N/CS26, 1315 East West Highway, Silver Spring, MD, 20910-3282.
