The referenced segment number has been out of service since August 30, 2017, as provided in Monforte's notification letter dated October 31, 2017 and previously was approved for a temporary cessation of operations until November 30, 2018 to complete repairs to Ship Shoal Block 277 A Platform. Monforte has almost completed the repairs and is ready to bring production back online but weather has caused delays.
