Dear Mr. Marchive:

Reference is made to EPL Oil & Gas, LLC's (EPL) Right-of-way (ROW) modification application received by this office February 18, 2020, for Pipeline Segment Number (PSN) 7821, ROW No. OCS-G28694.

Specifically, EPL requests a temporary cessation of operations for PSN 7821 until June 30, 2020, to modify the associated safety systems by installing a nitrogen lift system. The pipeline has been out of service since November 2, 2019.

The pipeline is described as follows:

Pursuant to 30 CFR 250.1000(b), EPL's application is hereby approved subject to the following conditions:

1. The annual rental required by 30 CFR 250.1012 shall continue to be due and payable in December of each calendar year.
2. If the associated pipeline has not been returned to service and is not being used for the purpose for which the pipeline ROW grant was made by June 30, 2020, the ROW grant shall be deemed expired in accordance with 30 CFR 250.1014. As a reminder, per 30 CFR 250.1010(h) the ROW holder must remove all pipelines and accessories associated with ROW OCS-G28694 within one (1) year of the effective date of the relinquishment or forfeiture (i.e. expiration). Furthermore, a decommission application must be submitted to the pipeline section to decommission PSN 7821 within 30 days from the effective date of the relinquishment or forfeiture (i.e. expiration).

3. If at any time prior to June 30, 2020, it is determined that the use of PSN 7821 is to be permanently discontinued, an application to decommission the pipeline and relinquish the pipeline ROW shall be submitted to this office for approval.

EPL Oil & Gas, LLC (EPL) (Operator No. 02266) as holder of Right-of-Way OCS-G28694, respectfully requests a temporary cessation through **June 30, 2020**.

The legal description of this ROW: ROW OCS-G28694 is a 200-foot wide and approximately 1.64 miles (8,639 feet) long corridor associated with the 4-inch Pipeline Segment No. (PSN) 7821. The purpose of the pipeline ROW OCS-G28694 is to maintain and operate PSN 7821 and to transport bulk gas originating at Platform M, terminating at Platform E, all located in Vermilion Area Block 38.

The pipeline right-of-way ceased transporting hydrocarbons on November 2, 2019 after Williams locked the valve at Cox's A Platform in VR 39 on SN12693 (ROW OCS-G 22115) utilized for gas buyback for the lifting of hydrocarbons in the VR0039 Field wells. It was permanently locked in order to prepare for the abandonment of Transco's Vermilion 22 Lateral, Transco Location 1003152, Meter 2852, BSEE PSN 4198 (ROW OCS-G03364).

EPL respectfully requests this temporary cessation to allow time needed for Cox to resume production and modify associated safety systems by installing a nitrogen lift system and continue producing several wells located at the M and K facilities on Vermilion Block 38, Lease OCS00204.

A modification to the safety systems on the affected structures is required. The nitrogen compressor system has been permitted and is currently pending approval.
