Dear Mr. Berry:

By letter dated July 3, 2025, BP Exploration & Production Inc. (BP) requests approval of a Suspension of Production (SOP) for the Keathley Canyon (KC) Block 102 Unit, Agreement No. 754315003. The Unit consists of Leases OCS-G 25777, 25781, 25782, 30910, 30911, 30917, 30926, 30927, and 33006, and was held by an SOP through July 31, 2025.

BP requests an SOP for sufficient time to construct, transport, and install the production facility. The SOP is also necessary to provide time to drill, complete, and commence production from unit wells.

In accordance with Articles IX, XVI, and XVII of the Unit Agreement and 30 CFR 250.174(a), an SOP and activity schedule for the KC Block 102 Unit are hereby approved from August 1, 2025, through December 31, 2026. BP is expected to follow the enclosed SOP activity schedule and must notify this office in writing (progress report) by the end of each month in which a deadline is scheduled.
