



8. That certain unrecorded Agreement Regarding Consulting and Exploration Agreement dated May 30, 2008, executed by and between David A. Pustka, et al, the individual members of Blue Streak Exploration, and LLOG Exploration Offshore, Inc.

The ORRI hereby assigned shall be free of all costs of operations and drilling and shall be computed by the same method and under the same conditions and circumstances as the royalty provided to be sold or delivered in the Lease (except that any Royalty Relief or Royalty Suspension Volumes granted by the Lessor shall have no effect on Assignor's obligation to pay the ORRI hereunder during the period of Royalty Relief or Royalty Suspension Volume), and shall be subject to any provisions therein regarding deductions for marketing or other Lessor approved deductible production related costs or expenses including a proportionate part of all applicable severance and production taxes.

Assignor, its successors and assigns shall have the right to pool, combine or unitize the above described Lease and any portion or portions of the lands covered thereby with other land, lease(s) or mineral interest in any manner and at any time before or after production, without the consent or approval of the Assignees, their heirs, or assigns. In the event the acreage covered by the above described Lease, or any portion thereof is pooled, combined or unitized with other lands, lease(s) or mineral interest to comprise a unit (or units), Assignees' ORRI assigned herein shall be reduced by a fraction, the numerator being the number of acres included in the unit to which the overriding royalty is applicable and the denominator being the total number of acres in the unit.

Assignor shall never be under any obligation to Assignees, their heirs or assigns, to maintain the above described Lease in force and effect by the payment of rentals, the drilling of wells or otherwise; the overriding royalty herein conveyed being due and payable out of production if and when it should be obtained by Assignor, its successors and assigns.

This Assignment may be executed in multiple counterparts, each of which shall for all purposes constitute one and the same instrument.

All provisions contained herein shall be binding on all heirs, successors and/or assigns of Assignees and Assignor.

TO HAVE AND TO HOLD unto Assignees, their heirs and assigns, without warranty of title, either expressed or implied, except as to all persons claiming by, through or under Assignor.

THIS assignment shall have an effective date of March 1, 2013.


